Explanation of significant increases in the budget:

Public Safety staffing increases related to 3 new full-time firefighter positions and the related 3.4% increase in State required contribution rate for public safety pension, results in an overall increase in public safety pension expenses of 10.13%. The FY21-22 total City proposed levy will be \$10.11, which includes the \$8.57 show above plus the Debt Service levy of \$1.54. This is a 5 cent decrease from FY20-21's levy.
