If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u>?	Yes. Well-child care, in- <u>network</u> <u>preventive care</u> , services subject to health and drug card <u>copayments</u> , outpatient MHCD services/colonoscopy/non-routine sigmoidoscopy/fecal occult, out-of- <u>network</u> routine mammogram and in- <u>network</u> independent lab for mental health/substance abuse services. Does this plan provide Minimum Essential Coverage? Yes
